

**THE CORPORATION OF THE TOWNSHIP OF RUSSELL**

**BY-LAW # 2019-049**

Being a by-law to authorize an agreement with the Nation Municipality for a new fire protection agreement for the provision of fire protection services for Russell residents in Limoges in order to attain compliance with the requirements of the *Fire Protection and Prevention Act, 1997*.

**WHEREAS** by-laws have been duly enacted by the parties pursuant to the provisions of Section 20 of the *Municipal Act, 2001*, as amended, to authorize an agreement between the parties; and

**WHEREAS** Section 2 (5) (a) of the *Fire Protection and Prevention Act, 1997* permits a municipality, under such conditions as may be specified in the agreement, to enter into an agreement for the provision of fire protection services to lands and/or premises that are situated outside the territorial limits of the municipality; and

**WHEREAS** Section 2(5) (b) of the *Fire Protection and Prevention Act, 1997* permits a municipality to receive such fire protection services, as may be specified in an agreement, from a fire department situated outside the territorial limits of the municipality; and

**WHEREAS** Section 2 (1) (b) of the *Fire Protection and Prevention Act, 1997* permits a municipality to provide such fire protection services, as may be specified in an agreement outside the territorial limits of the municipality; and

**WHEREAS** Section 2 (1) (a) of the *Fire Protection and Prevention Act, 1997* states that every municipality shall establish a program in the municipality which must include public education with respect of fire safety and provide such other fire protection services as it determines may be necessary in accordance with its needs and circumstances; and

**WHEREAS** Nation operates a fire protection service with assets suitable to meet municipal responsibilities required by the *Fire Protection and Prevention Act, 1997* through a fire department situated within the Village of Limoges; and

**WHEREAS** Russell and Nation have an existing agreement concerning fire protection services dated January 1, 2016; and

**WHEREAS**, Russell and Nation deem it necessary to enter into a new fire protection agreement for the provision of fire protection services for Russell residents in Limoges in order to attain compliance with the requirements of the *Fire Protection and Prevention Act, 1997*; now therefore be it

**RESOLVED THAT THE COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF RUSSELL HEREBY ENACTS AS FOLLOWS:**

1. **THAT** the Mayor and the Clerk of the Corporation of the Township of Russell be and are hereby authorized to sign the agreement therefore replacing the existing fire protection services agreement.
2. **THAT** this By-law shall be effective upon final reading thereof.
3. **THAT** By-law 2016-079 being a By-law to authorize an agreement with the Nation Municipality for a new fire protection agreement for the provision of fire protection services for Russell residents in Limoges in order to attain compliance with the requirements of the *Fire Protection and Prevention Act, 1997*, previously approved on June 20, 2016, be and the same is hereby repealed.
